Minnesota Chippewa Tribe Constitutional Convention

Ahniin, Boozhoo? Niiganabiik indizhinikaaz
Makwa Doodem, Aasabiikone
Saga'iganing Indoonjiba. English:
Mildred "Millie" Holmes is my
name. I'm Bear Clan and I'm from
Nett Lake. I was appointed as a
delegate to the Minnesota Chippewa Tribe Constitutional Convention in 2017 and have attended
every meeting either in person or
by Zoom.

I volunteered to write a series of articles for Tribal newspapers presenting a summary of the Convention Delegates actions to date. I will not be giving a point-by-point summary nor will I be educating people on being Anishinaabe, Ojibwe, or tell vou what your Clan is. This information is available to you on the internet by which resource I have listed within the pertinent section. Or you can get your tobacco ready along with gifts, if necessary, to ask an Elder to give you instruction as to specifics. Those of you who were fortunate to have a parent, grandparent, aunt, or uncle to teach you these things, are asked to have patience with those who weren't so instructed due to circumstances beyond their control.

Background

Since the various delegation to the Constitutional Convention started meeting in 2018/19, some time was spent on educating the Delegates. Then time was spent on the definition of Anishinaabe governmental system as it pertains to the Clans. Eventually, it was decided to table the breaking into Clans when a show of hands was taken as to Clan representation among the delegates. The majority, about 90%, were Makwa Doodem, Bear Clan with one Turtle, one Crane, one or two others.

Some educational materials were developed by Anishinaabe Zaa-gibagaang https://zaagibagaang.com/ gives an overview and history of the Anishinabeg and the Minnesota Chippewa Tribe. Their About Us page, https://zaagibagaang.com/aboutus, lists

some of our core values. They are available for presenting if a group would like to learn more about the Zaagibagaang or the MCT in person.

Unity As a Tribe

Minnesota Chippewa Tribe

- Umbrella Constitution
- No specific treaty with the United States of America
- Six Bands/Reservations were coerced into becoming one entity without relinquishing their individual treaty rights, privileges, and obligations because the U.S. government wanted an easier way to distribute annuity funding.

Umbrella Constitution

Some time was spent for each delegation to voice their opinion of the Minnesota Chippewa Tribe as an entity. Once it became clear that opinions were pretty much being repeated, the Convention Delegates as a whole used many of these in the shaping of the vision for the new Constitution.

There are three versions of a Constitution currently being worked on by the Drafting Committee:

- I. Version along the lines of our current Constitution
- II. Version that includes Tribal Clan system of government
- III. Version that is a hybrid of the

two.

During the pre-Pandemic meetings, there were many attendees of community members who gave their input and these were also considered and incorporated into our vision. What remains now is to get these into a Draft document to be presented to the people for their approval and get a vote on which one to adopt.

There is also the option to amend our current document which is generally met with disapproval by the more vocal members of the Minnesota Chippewa Tribe.

One viewpoint many delegates agreed with is that we'd like to make this document as complete as possible, so our "DESCEN-DANTS" don't have to deal with the very same issues as we've been dealing with these last 90 years.

Differences

Individual Bands

- Concerns specific to each Reservation
- Each reservation has its own treaty establishing the Reservation boundary.
- Each Reservation has their own wants and needs.

Individual Constitutions

The Constitutional Convention

Delegates have agreed these items can be addressed in their own Constitution specific to that Reservation. See "Why Treaties Matter" website at https://treatiesmatter. org/treaties for the list of all the treaties that pertain to us in Minnesota.

The Delegates have also agreed that the concept behind the organization of the Minnesota Chippewa Tribe will not be set aside in our effort to redefine the current Constitution. We need to keep united as a People and work through our differences.

Currently, the Minnesota Chippewa Tribe Constitution provides that each Reservation will have its own By-Laws. "A constitution and/or bylaw is/are how most groups write down their rules. The constitution contains the fundamental principles which govern a group's operation. The bylaws establish the specific rules of guidance by which the group is to function*." The meetings follow Robert's Rules of Order**. These cover the parliamentary procedures. Now, I'm unsure if this was taught in the current curriculum of schools and therefore might be a bit confusing. Copies of the official book are available at https://

robertsrules.com/. I mention this because it might have to be adopted and put into effect for the Constitution, so it behooves us to learn these.

Now, there might be one or two who say it doesn't pertain to traditional. I say, there were rules that

were followed. Not every meeting was allowed to degenerate into fisticuffs. Thus a need to learn the Clan system.

Once the umbrella Constitution is decided on, each Band/Reservation will meet and write their own Constitution and/or By-Laws.

Contributions You Can Make

Once the Bands start working

on their own Constitution/By-Laws, each community member is invited to continue to voice their opinions and views in the making of this document. Perhaps we'll need a discussion whether to reference our own treaties in this document or if each Band writes its own document incorporating its treaty at the local level.

You can check out the treaties at the link I mentioned above. Information is also posted on the Minnesota Chippewa Tribe website at https://www.mnchippewatribe.org/. There is a Facebook page which requires an invitation from a member. MCT Constitutional Convention Delegate meet every third Friday of the month which

is hosted by each Reservation and urban area in turn.

Getting to know: the FDL Housing Division

¬he Fond du Lac Housing Division (FDLHD) has undergone many improvements over the last handful of years to make the process of renting and owning an FDLHD home clearer. Mary Diver, the Housing Director since 2018 has resumed this position again and knows the frustration of big changes. People come in and ask several questions regarding the process now and the staff replies "It's policy." All policies are available to read at the office or on the FDL website.

"These policies and procedures were changed shortly before I returned as Director in 2018. They are made more assertive then the past ones," Diver said. "We now have a court for Evictions, this is beneficial for both the housing staff and the tenant. It removes the potential of anyone being politically involved. We never had that before."

One of the biggest changes to housing is not having the RBC involved with everyday operations of the division. Although they are the tribal designated housing entity they have allowed the division to operate on policy and procedure already put in place. Any and all changes

filter through them through the Housing Committee. Additionally, enforcing these policies have been key in staying in compliance. These range from rent payments, security deposits, tenant abuse, eligibility, occupancy and admissions and termination etc.

The Housing Committee is the arm of the RBC. The committee doesn't deal with the administrative side of housing. Everything the committee does runs on policy and procedure from Petition for Recognition, grievance hearings, selections, and request to address. They recently made change to the committee by having 6 members on the committee from 5 members. Two members for each district. they now have more than one meeting a month in order to stay on top of the required responsibilities they hold. It also allows more representation for each district.

The Housing Division has many Federal Regulations to follow under HUD's Program Native American Housing and Self Determination Act of 1996 (NAHASDA). So, while FDL runs housing like any other division, the rules and policies that we follow are not only set by NAHASDA but the Band must write their own as long as they

fall under Federal Regulations. For example, income is set by Federal Regulations. Housing is not allowed to charge anyone over 30% of income. We set ours at 25%. Annual income cannot exceed what the government lists as the income amount. Eg. One-bedroom applicant cannot exceed \$50,400.00 income to be eligible for the pro-

gram. The Band can also make policy regarding income, an example would be housing does not include Per Capita as income. The Band charges elderly members 1.00 in rent. These are just a few mentioned.

"We are low

income Tribal housing, we are not no income housing, I say this because more policies are being developed to make changes to that," Diver said of the policy change. "A lot of our rental units as well as Homeowner units pay zero rent. This is going to change. Some income will be required."

Housing has 339 units ranging

from rental to homeowner and 2 elderly buildings with a 3rd being built in Brookston. You must be 52 or older to qualify for the Elderly's. The vacancies we have now are either due to death, crime/drug/illegally activities with an occasional abandonment.

Housing works with Law Enforcement on obtaining police

reports. They will send over reports they obtain for one of our units so we are aware of what's going on. Housing needs teamwork in order to be able to provide safe and healthy communities.

The newest of all changes is Ordinance 02/09. This ordinance

covers all areas of crime, drugs, and violence. It's for occupancy and admissions. It relates to the factors we all endure in housing and applying for housing. A lot of changes have been made to the Housing Program and many more will come in the foreseeable future. Times have changed since 1980. We must move

forward with these changes and make it what our Mission Statement says:

The Mission of the Housing Program of the Fond du Lac Band of Lake Superior Chippewa is to develop and maintain affordable housing activities. These activities will be solely for the purpose of providing descent, safe, sanitary housing and support services for the families of the Fond du Lac Tribe in a manner that promotes serviceability, economy, efficiency, stability and the economic and social well-being of the Fond du Lac Indian People.

Fond du Lac Housing provides a necessity to Band members in need of housing that may not be able to afford one otherwise, but there are rules to follow that may have been set out by RBC, Housing Committee, Tribal Attorneys, and NAHASDA.

Diver look forward to add additional articles to this paper on this interest. Housing is a big deal on this Reservation and we need to preserve it and make it last for generations to come.

Boys' basketball season starts strong

he Fond du Lac Ojibwe School boys' basketball program has had many successful years over the past decade and plans to continue that this year. No one understands that more than first year Head Coach Cam Thompson.

While Thompson hadn't ever coached at the varsity level before this year, he has experience coaching AAU and as an assistant coach, and Thompson even played for FDL when the team played at the state tournament. All that time spent around the game gives Thompson great perspective on how the team is doing and he and the boys have high hopes for this season.

"We lost a few close games early in the season. Really, it was just the last two minutes of the game that slipped away," Thompson said about how the team is starting to find its groove here at about the midway point of the season. "But overall we're playing really well and things are starting to look good."

The team, which has a strong eight player rotation has lofty goals set for this season, goals that Thompson knows they can achieve.

"Our goal is to go all the way. We want to make it back to the state tournament and just bring that championship DNA back to Fond du Lac where it deserves to be," Thompson said of the teams focus here with only a few weeks left to go. "The boys are really working hard and coming to work every single day. So that's what we're looking for. We don't see any reason why we can't make it back to the state tournament."

The road to the state tournament

won't be easy with games against teams like Cherry, Nevis, and Mountain Iron-Buhl, but Thompson knows if the team remains focused and plays the way they're capable of, big things await them.

"We'll have some tough matchups, but as long as we don't beat ourselves, I don't see anyone beating us," Thompson said of those top teams in the section. "Those teams have won some big games recently, but like I said, if we play our game, I don't think anyone's going to beat us."

After struggling to finish games earlier in the year, FDL has been able to close out games more recently, including beating a very good Mountain Iron-Buhl in a close game at Fond du Lac in mid-January. That late game focus and solid team play has come from leadership and the team putting in long hours of hard work.

"They're teaching the younger guys as we go and they're growing in this season," Thompson said of the seniors guiding the underclassman through a rocky start to the season. "I'm not going to be worried about it when the time comes, it's just a learning curve. The younger guys just need to get more of that game experience too. It'll be a big thing for these younger guys, being in those pressure situations where they have never been before. Once that happens, we're going to be alright."

FDL will also continue to see that success grow as the team continues to improve on the defense end of the floor as they've definitely not had any problems scoring.

"We're definitely stronger on offense. I feel like that's just a DNA that we've been falling back on for a while. It's always been an of-



fensive cavalry for Fond du Lac," Thompson said of the success the team has found putting up points. "We still have that DNA, but we're definitely locking in and focusing more on defense. We're putting the work in there and really, putting a focus on our defensive end. We know if they cannot score, we control the game."

Thompson noted that the team has had success at times on defense, but that sometimes rebounding is the problem.

"We've just got to attack the rebounds. From what I've seen from the team this year is sometimes teams are getting 2-3 opportunities on the offensive end, that's hard to win that way," Thompson said of how the team was getting beat earlier in the year. "We'll put a lot of effort in, we just have to crash the boards, and when that happens, I don't think anyone's going to beat us as long as we can control what we control. We're a very good team."

The FDL boys' team is very

talented with great seniors and important additions from underclassmen, so Thompson could name almost any of his players as a reason for the team's success, but one player has been on an impressive run of games lately and coach couldn't ignore his success.

"Jordell Brown, he's a junior. He's a huge key on the offensive end for us and a big part of our rebounding," Thompson said of his Junior leader who'd just come off a 33 point game against Northwoods.

"Mukwa Bellanger too, even if he doesn't put up numbers on the offensive end, he always comes to work and gives 100% every time he's on the court, every time he's in practice," Thomson said about another star on the team.

"Dannin Savage, he's been big for us too. He's 6'4" in a single A class. There's not many who are going to be taller than him. So he's big for us in the post and definitely a huge help for the rebounds," Thompson said of his big man.

Almost everyone got praise from Thompson who noted that it's their team effort that has gotten them some wins lately.

"I'm just looking forward to the rest of the season and watching them continue to grow as a team," Thompson said of his excitement as the team starts to enter the final stages of the season. "We have a well-rounded group of guys, different age groups. We also have had some good play from a freshman guard Chazz Martineau. He's actually my younger brother. He's our sixth or seventh man off the bench so he's going to be huge too, to come in and relieve some of our guards."

Fond du Lac knows what it takes to win, and Thompson sees that the group has the talent to make it to the state tournament once again. It's once again another exciting year for Fond du Lac basketball and we can't wait to see what they're capable of accomplishing this year.

Oh, How I Hate to Say Goodbye

orty years of research, thirteen years of stories, photography, friendships, adventures and love for the old village of Fond du Lac, this reservation and beyond. Getting to know the ancestors, people and places has been rewarding for sure. It is time to move on to another path in life. Many people are interested in their family history and ties to the past. I was happy to share glimpses or bits of history or maybe some answers or clues to your family's life or history but oh what a wonderful journey.

Thanks to Kevin Dupuis, Tami Diver and the Reservation Business Committee. Forty years of researching, it's like my child. Such emotion passing on a part of my heart and soul.

The Fond du Lac Band is in the process of buying my 40 years' worth of Fond du Lac Indigenous research and photography of significant tribal events: My first tribal, three-day event photographed, happened in August of 1984 up at Spirit Mountain and the event was called Ni-Mi-Win. In all the other pow-wows, none has surpassed this incredible, majestic pow-wow at Spirit Mountain.

It was good that this administration sent several reservation employees to my home. This shows that the administration is seeing that the band's money will be wisely spent. Three different visits to my home have been made

by six different Fond du Lac employees. The employees that came are Wayne Dupuis, Reggie Defoe, Evan Schroeder, Lance Northbird and Kami and Lynn Diver. My home and office have been open for view. My office area has been photographed; four packed, four drawer file cabinet drawers were opened to show the historical contents.

One of the drawers with just the last names starting with A-B contained 163 family file folders and was more carefully viewed. I have six, full drawers of reservation family files all in alphabetical order with documentation and history. One person always wondered about the deaths of two close relatives so many years ago. I pulled out two manilla file folders on that family and the news clippings regarding their deaths were both there in the folders. Long awaited answers were found. I also opened up other file drawers to show what was there. There are files of specific topics: treaty files, religious files, census files, birth, death and baptismal records, battles, fur trading files, etc. There are shelves of 3 ring binders and some in drawers. One 3 ring binder was requested to be more carefully viewed. There is also one long shelf of related books included. Requests were granted and an informal time of questions for me occurred around the kitchen table for all three visits.

I have shown my research skills and love for the people of this reservation, community and beyond through thirteen years of well documented submissions and quality photography to the tribal newspaper Nahgahchiwanong. I am not a reservation employee and have been paid for these monthly submissions.

I have given hundreds of pro-bono (free) research hours, documentation and information to folks in this reservation for their success in significant tribal historical projects such as Biauswa Bridge renaming, Roussain Cemetery, Wisconsin Point, Minnesota Point and the tragic desecration of the old FDL Cemetery. As well as helping surrounding areas in getting the word out for justice, education and diversity. All this started out for the love of the old village of Fond du Lac in southwestern Duluth where I grew up and has been passionately continued through the years.

I know its going to a wonderful culture that is hungry for knowledge and clues to its past and going on to the future. For thirteen years, it has been my honor to provide researched stories and photographs for this newspaper. Thanks to the editors who have been so kind and open to my ideas and thinking "out of the box".

Embarrassed of the Anglo forefathers who were drenched in greed, assimilation and ruination of this unique culture. Wrapped in a blanket of warmth for looking at life in another way as I tried to do it with justice and understanding and learned along the way as both teacher and student.

And how my mother gave

birth to me in the back alley of Duluth's St. Luke's Hospital and they sent me to the contamination ward instead of the nursery. This was the beginning of my life. How adversity made me stronger and more resilient.

And how Gitichi Manitou lead the Carlson family to the old village of Fond du Lac in 1950. Wow what a place to grow up! A place filled with history and adventure and joy. Thanks to my dad and mom Walter H. Carlson and Erna (Olson) Carlson and sisters Mae, Joyce, Esther, Elizabeth and Margaret. Many thanks to my wonderful sons Jimmy and Keane Carlson.

And how I was the nosey one who wanted answers to questions and drenched myself with the culture and wonder of the land, air, water and ancestors of the past. Getting to know more elders and picking out a few historical tidbits, ones that caught my eye, made me cry or brought a smile that led me to a story that needed to be told.

And living next to Mission Creek filled with history and the troubled times with the missionaries who did not understand the culture or people they wanted to change or destroy. Just think what tenacity with all that adversity and yet the Indigenous survived and prospered.

And living next to an incredible family whose roots go way back to old Fond du Lac, the Rushenbergs. Dearest Grandma Hulda and Mildred (Rushenberg) Behning who was so

happy to share life experiences in the old village.

And best friend Vicky Hubbard whose family lived right on the old Fur Trading Post land next to the beautiful St. Louis River. We enjoyed such freedom to run around and experienced life and adventure on such sacred grounds.

And neighbors to the Shea family whose matriarch was Violet (Ostedt) Shea. She took a lot of photos and befriended Charles Roy whose connection to old Fond du Lac goes way back to the famous Roy family of Vincent Sr. and Jr.

And the employees and friends of the reservation and community that shared their insight and stories or information. During the search, how I was filled with emotion at such atrocities and how I cried; then laughed with joy and such excitement to find answers while looking for something else.

And what important and necessary knowledge to finally discover diversity after a "Anglo male" education in the public schools. To enjoy and share the incredible "melting pot" and significance of the historic western part of Duluth and beyond. The time has come for its glory to shine.

Gitigaaning Grows Food Sovereignty

itigaaning, the place of the gardens, is a community hub for Tribal food sovereignty. Fond du Lac purchased the 36-acre farm in 2017 and now hosts agricultural programs, supporting 20 local producers and growing food in the thousands of pounds.

In 2022, the Agricultural Division was created and Marcia Eiynck, a descendant of the Grand Portage Band, was hired as the Director.

"I am so grateful for the opportunity to bring my experience and passion for Tribal food sovereignty to Fond du Lac," said Eiynck. "I moved to the area to care for my Elders, allowing me to take on this position after serving my community in a similar role. I look forward to providing ongoing support to critical programming, exploring agricultural enterprises and continuing to build a food system rooted in Anishinaabe values."

The Fond du Lac Food Sovereignty Initiative (FSI), an interdepartmental group created in 2015 that includes the Planning Division, Health and Human Services, Education, Resource Management, and Fond du Lac Tribal & Community College Extension staff, has provided the momentum up to this point and will continue to be a significant driver of this work with its new member, the Agricultural Division.

Tribal food sovereignty builds on the efforts of generations of Ojibwe seedkeepers, gardeners, blueberry pickers, fire keepers, medicine gatherers, entrepreneurs and so many more committed to preserving Anishinaabe lifeways and providing for our people through food for millennia. The Agricultural Division is one entity of the countless necessary to continue this legacy.

Looking Back

In 2022, Gitigaaning staff harvested more than 2,700 pounds of produce from the Gitigaan Program demonstration plot, Bimiginogaan, and Cloquet seed garden. Much of this was donated to the Ojibwe School, with the remainder of the food being used in community feasts, at Gitigaan classes, and provided to other Fond du Lac programs.

Thanks to Bimiginogaan, a domeshaped greenhouse built with grant funds, this year's growing season was extended from May to November, providing lettuce, peppers, cucumbers and more, earlier and later into the season.

The Gitigaan Program provided 150-plus Fond du Lac families and community members with gardening kits at the annual Plant & Seed Giveaway. In collaboration with the Bimaaji'idiwin Producer Training Program, more than 15 classes and demonstrations were hosted about Indigenous growing methods, soil health, and more. The program provided garden tilling to Fond du Lac Tribal members.

Community Kitchen

Na'enimonigamig, Fond du Lac's kitchen/cannery facility, is open to all Fond du Lac community members, including enrollees, descendants, family members, Native producers, and Bimaaji'idiwin Producer Program participants, to preserve their harvest and create value-added products. There is a wide range of equipment available for use, including canning equipment, pressure cookers, dehydrators, vacuum sealers, a butchering facility, sugar bush processing equipment (filter press, bottler, sugar maker), walk-in refrigerator, freezer, root cellar, and more! In 2022, hundreds of people toured

and used Na'enimonigamig. Many Fond du Lac programs and community members used the space to preserve food and create valueadded products, such as flash-frozen chickens, dehydrated apples, pickled peppers, and bottled maple syrup.

We hosted over 20 tours and welcomed visitors from around the world to talk about food sovereignty and our work at Gitigaaning. Early in the spring asemaa (nicotiana rustica) and pollinator plants were planted in front of the facility. We harvested and donated dozens of tobacco plants to Anishinaabewigamig and have dried leaves available for community members at Na'enimonigamig. Seed saving continues and Tribal seeds, including corn, beans, squash, and asemaa/ tobacco, are now available anytime for community members.

Looking Ahead

In 2023, the Agricultural Division is building its foundation by diversifying funding sources, hiring full-time staff, and continuing to grow food for the Fond du Lac community at Gitigaaning and other agricultural sites.

Winter Ambient Air Biboon (winter) is here! What does that mean for our ambient air?

Tt can be easy to notice air quality issues in the summer, **▲** like wildfire smoke or hazy smog in cities, but trickier to notice similar issues in biboon. One issue that may fly under our radar is air stagnation. As you might recall from school lessons, cold air is denser than warm air, so warm air tends to rise, while cold air tends to sink. This cold air moves slowly, stays close to the ground, and forces warm air to escape over it, causing trapped cold air. This trapping reduces the ability of air to mix well, causing pollutants to stick around longer and accumulate. Biboon storms and wind events can stir up the air, which helps to circulate the accumulated pollutants. Between weather events, lingering pollut-

ants are especially relevant, as

more people idle vehicles and heat demands increase. This January, northwest and central Minnesota experienced the worst stagnation event since 2005, triggering an Air Quality Alert and air quality values in the Red AQI (unhealthy for all) category. When pollutants like vehicle exhaust, smoke from wood stoves, and factory emissions cannot properly disperse, poor air quality can develop for longer durations.

A couple steps you can take to help address these issues include reducing the time you idle your vehicle and reducing your energy consumption. Most of us appreciate a warm car, but being conscious of how long we leave our car running and putting on another layer can help us reduce pollution from our vehicles. You'll

save on gas, too!

Other issues with biboon air can be easy to detect, like dryness and difficulty with breathing cold air. Skin that is often exposed to the cold may become dryer during biboon. To mitigate this dryness, make sure to stay hydrated and cover up exposed skin in cold weather; these steps are usually great to do, anyways! As for breathing, the air you inhale needs to have a certain humidity, and have the same temperature as your body before it reaches your lungs (Runner's World, "Why Breathing Cold Air Hurts When You're Running"). That means your body must do extra work to create the right temperature and moisture level to supplement the cool, dry air we inhale. This process can irritate your respiratory system and trigger underlying respiratory issues. To help reduce these issues, you can cover your mouth/nose with a ski mask, buff, or scarf to help warm the air as you breathe.

Overall, the air quality can worsen in biboon, as air cannot move as freely as it can during warmer months. Being aware of and reduce vehicle idling and energy consumption can improve our biboon air. While you may be used to keeping an eve out for air alerts in the warm months, it's good to check on our air quality in biboon, as well! It's important to stay covered up in cold weather for many reasons, but noted here, it helps our bodies conserve moisture and process cold air better. Biboon is a necessary season for our part of the world. It can be a

tough time of the year, but staying warm and being conscious of our environmental impact is super important! Booch igo ji-ayaamagak biinanaamowin! (There needs to be clean air!)



Energy Assistance

here is still time to apply for the State Energy Assistance program. Applications and crisis benefits will be available through May 31, 2023. Qualifying for the program is based on income. Currently a family of four can make up to \$14,698 in the three months prior to submitting the application.

Energy Assistance cannot only help with fuel bills but can also help with electric bills. Applicants may request that a percentage of the benefit be sent to the electric company. Electric companies can still disconnect you in the winter. Households must contact the electric company and request to

be placed on the "Cold Weather Rule."



Health News

Obesity and Cancer

id you know that being overweight or obese increases your risks for getting cancer?

Ninety percent of new obesity-related cancers occur in men and women who are 50 years old or older.

More than 650,000 obesity-associated cancers occur in the U.S each year, including more than 200,000 among men and 450,000 for women.

The CDC has found that about 42% of adults and about 19% of children have obesity. Adults with obesity have a higher risk of many serious diseases and heath conditions, including cancer, than people with a healthy weight.

American Indians and Alaskan Natives have much higher rates of getting lung, colorectal, liver, stomach, kidney, and many other types of cancer compared to the non-Hispanic white people in the United States.

Overweight and obesity for our children is on the rise. Being obese or overweight as a child or teen can increase the chances of cancers later in life. The higher amounts of body fat are associated to increased risks of a number of different cancers including:

Risk factors include: commercial tobacco use, drinking sweetened beverages, alcohol use, lack of physical activity, diabetes, obesity, exposure to carcinogens (substances that can cause cancer), viral hepatitis infection and helicobacter pylori (H-pylori-a leading risk factor to stomach cancer).

- Other risk factors can also contribute to these cancers. Some of these are hormone levels, changes in genes (called mutations), and long-lasting infections.
- Being overweight or having obesity doesn't mean that someone will definitely get cancer, but it does mean that they are more likely to get cancer than if they were at a healthy weight.

What can we do to lower these risks?

- Understand the benefits to screening services starting as young as children 6 years old to adult age
- Seek out commercial tobacco prevention programs
- Make healthier lifestyle choices- follow a healthy eating plan and taking part in regular physical activity.

Hearts

Pebruary reminds me of hearts. Everyone needs a heart. Here are several tips on keeping your heart healthy from the Mayo Clinic:

- 1. Control portion sizes. Too much food equals more calories than needed, thus weight gain.
- a. Try using smaller plates and bowls
- b. Fill up on the veggies
- c. Limit high calorie foods
- d. Remember to include a variety of foods.
- 2. Eat more fruits and vegetables. Fruits and vegetables are great sources of vitamins and minerals. They also have fiber, which can help you feel full longer.
- a. Pre-wash and pre-portion veggies. Place in snack-size containers or baggies as a quick snack on the go b. Fill half of your plate up with vegetables
- c. Throw extra vegetables in all of your meals. Add more vegetables to pasta dishes, soups, casseroles and sandwiches, for example.

- 3. Choose whole grains more often. Aim for at least half of your grains to be whole grains.
- a. Read labels. Look for whole grains as one of the first ingredients
- b. Don't forget other forms of grain such as brown rice, barley, oatmeal and guinoa
- 4. Follow the American Heart Association guidelines and limit unhealthy fats. Unhealthy fats include saturated fats and trans fats.
- a. Trim excess fat off meats
- b. Use lean cuts of meat
- c. Use less butter, margarine and shortening when cooking
- d. Check labels and avoid snack or dessert foods such as cakes, cookies chips and crackers that have trans fats e. Healthier fats include olive, canola and vegetable oils, nuts, seeds and avocados.
- 5. Choose low-fat protein sources. This includes lean meat, poultry, fish, low-fat or no fat dairy products, legumes, beans, peas, lentils and eggs.
- a. Remove skin of chicken and turkey
- b. Trim off excess fat on meats
- c. Avoid fried foods
- d. Limit processed meats such as

- hot dogs, sausage and bacon.
- 6. Limit and reduce sodium intake (salt). The American Heart Association recommends no more than 2300 mg of sodium a day, even less, 1500mg a day for some adults.
- a. Read food labels
- b. Limit processed foods
- c. Canned foods tend to be higher in
- sodium so read labels and limit intake d. Reduce the amount of salt used in
- cooking and on foods at mealtime
 e. Check out other ways to flavor
- foods with different herbs and spices.
 7. Plan ahead. Planning meals ahead
- 7. Plan ahead. Planning meals ahea helps prevent the quick, unhealthy food when in a rush.
- a. Cook more than needed and use leftovers the next day.
- 8. Allow yourself an occasional treat. It is okay to have a smaller portion of your favorite treat as long as it is not every day!

MN launches new COVID-19 telehealth treatment pilot program

Beginning immediately, Minnesotans who test positive for COVID-19, either with a home test or a positive test from a lab, can download the Cue Health app and sign up with their Minnesota address to have a virtual consultation with a licensed clinician who will evaluate them to determine if therapeutic treatment is a good option. If they are a good candidate for therapeutics, the clinician can issue that prescription to the patient's local pharmacy. In some areas of the state, those prescription medications can be delivered to the person's home.

All services, including the consultation, medication and delivery, will come at no cost to the Minnesotans who use this service. This pilot program is available to all Minnesota residents.

Beet and watermelon salad

Prep time: 20 minutes **Ready in:** 1 hour

Serves: 6 Ingredients:

2 cups red beets

1/2 large watermelon, diced

3 cups spinach

1 small red onion

1 cup basil leaves, thinly chopped

1/2 cup fresh mint

1 package crumbled goat cheese

4 tablespoons olive oil

1 orange, halved

Directions:

Preheat oven to 400°F. Wash beets, then slice off just a bit from the tops and bottoms. Wrap beets loosely in foil and roast on the middle rack of the oven for 30-45 minutes or until tender, then let cool. Once beets have cooled, remove skin and dice them to desired length. Combine watermelon and beets together in a large bowl. Chop mint and basil into 1-inch long strips, or smaller depending on desired length. Dice red onion into small pieces. Combine watermelon, beets, onions and herbs together with spinach. Drizzle olive oil over the top of the mixture. Cut orange in half and add juice from 1/2 of the orange to the salad. Add 1 package of crumbled goat cheese. Toss, serve and enjoy! Optional dressings or garnishings can include: Pomegranate seeds

Tobacco is not just a health issue

The commercial tobacco use has far-reaching effects, not just on personal health, but on the health of mother earth. Tobacco is an environmental issue. How commercial tobacco is an environmental issue is one in which affects on waterways, cigarette butt waste, tree removals, and the thousands of pounds of toxic chemicals that are produced to create cigarettes, cigars, and electronic cigarette devices. For example, vape devices are made of plastic and are not biodegradable. According to the UK publication IndeJuice, the components of disposable vapes are materials like plastic, metal, cotton, lithium-ion batteries, sticky tape, wires and cardboard. https://indejuice.com/uk/vape guides/disposable...

The Truth initiative, a non-profit advocacy organization states that four-billion cigarette butts were collected in beaches and waterways globally – making them the world's second most common type of litter after food wrappers.

- 600 million trees are chopped down annually by the tobacco industry for cigarette paper
- 815,985 pounds of toxic chemicals were released from commercial tobacco factories in 2019
- 2.7 million tons of consumer electronic waste, including e-cigarette waste, that ends up in landfills, or is incinerated.

The health of the environment is endangered from commercial tobacco when it is not disposed of properly.

On March 31 Take Down Tobacco National Day of Action marks the day that Tobacco-Free kids empowers communities to "kick butts" – to slow the rates of youth starting smoking. The "Kick Butts day" now refreshed as "Take Down Tobacco" calls to awareness community health impacts of smoking, including negative environment effects.

Community health projects that address sacred use of tobacco and awareness of traditional uses of the sacred plant can be simple activities like gathering and making traditional tobacco from red willow bark or growing asemaa (sacred tobacco) plants. These steps are ways communities reclaim the relationship to forgotten traditions. Many Native communities in the U.S. are re-thinking their relationship with tobacco. Positive outcomes of a commercial tobacco free community are seen here on the Fond du Lac Reservation as some businesses are now smoke free.



Judith Marie Northrup, age 79, of Cloquet, Minnesota died on Sunday, January 15, 2023, at her home surrounded by family. She was






