Dear Fond du Lac Band Member:

The Fond du Lac Reservation Business Committee will make a stimulus payment in the amount of \$3200 to qualifying Band members. The stimulus payment will be made using funds the Band received through the American Rescue Plan Act of 2021 (ARPA). In order to qualify for the stimulus payment, you must:

- (1) Be a Fond du Lac Band Member over the age of 18 on the date of your application;
- (2) Have turned 18 by December 31, 2021;
- (3) Not be under a guardianship or conservatorship;
- (4) Complete the Stimulus Payment Request Form and provide the following:
 - a. Your first name, middle name, last name, and any suffix;
 - b. Your mailing address;
 - c. A description of one or more ways that you experienced a negative economic impact as a result of the COVID-19 pandemic;
 - d. A request for a full payment of \$3200 (or a lesser amount if the negative economic impact on you was less to meet ARPA rules);
 - e. The last four digits of your social security number;
 - f. Your birthdate;
 - g. A phone number where you can be reached;
 - h. Your signature; and
 - i. The date of your signature; and
- (5) Submit the completed Stimulus Payment Request Form to the Band's Payroll Department by mail, fax, e-mail, or delivery to the Fond du Lac Tribal Center by March 1, 2022.

If the Payroll Department receives a properly completed form by the 1st of the month, the stimulus payment will be processed that month. If you receive per capita payments by FOCUS card, your stimulus payment will be loaded onto your FOCUS card with your per capita payment that month. If you receive per capita payments by check, you will be mailed a check.

The stimulus payment will not be subject to income tax, but may affect your eligibility for public benefits. Band members who receive public assistance such as TANF, SSI or General Assistance may contact the appropriate agency and seek advice on how to deal with the impact that this needs-based, ARPA-funded payment will have on their assistance.
